Our Special Needs Committee and the Lorain multi-district provided an American sign language interpreter for a half dozen members at the dinner.

Area Officer Reports

REGISTRAR'S YEAR IN REVIEW

I'm not sure if our newsletter editor will let me double-dip, but here is a review of the last year from the Area Registrar's perspective. Area 54 is comprised of 62 districts in 20 counties in Northeast Ohio. It stretches from the shores of Lake Erie to the banks of the Ohio River. There are approximately 1450 groups serving over 22,000 members of AA.

The job of the area registrar is to provide accurate information concerning these groups to the General Service Office (GSO) in New York. We keep GSO Group Services hopping. Our area submits on average over 250 group changes every month. Consequently, I encourage the DCM of each district to visit the groups in his neighborhood frequently to ensure that the lines of communication stay open. When a group has an active GSR, that group is ensured a steady stream of valuable information about AA as a whole from GSO, from the Area and from the district. It's so important that we maintain an accurate record of who the GSR is and where s/he lives to get that information out to the groups in a timely fashion. AAWS publishes a yearly three-volume directory of groups with contact information. Thus, GSO asks for a phone number and full name to provide this confidential service to the alcoholic who might be traveling through Northeast Ohio. This directory also serves as a compact resource for the delegate and the treasurer since it contains service numbers for all the groups listed. I reach for my Eastern Directory all the time to help members locate their group's service number or district number. I was recently contacted by GSO to help them 'clean up' the area database. It seems there are over 350 groups registered with NY from our area that do not have a listed GSR. We know that most if not all of these meetings are still active. But we have no contact name. thus no communication. GSO will remove these groups from the directory listing if they do not hear back from them soon. I urge you all to encourage the members of all the groups you attend please, register your group and keep the lines of communication open. Your GSR is your Voice and your Vote to AA as a whole.

Speaking of databases...our area will be

receiving a new type of database from GSO very soon. Group Services in NY promises it will function better and faster than the DOS-based version in use for many years. This new platform is Windows compatible in Microsoft Access, a very powerful program. If you attended the Regional Forum last summer, you had an opportunity to get a sneak peak at this program.

Our hope, looking forward to 2004, is have a clean database of all the meetings and groups in Northeast Ohio, to better serve the still sick and suffering alcoholic. "Some day we hope that every alcoholic who journeys will find a Fellowship of Alcoholics Anonymous at his destination." – page 162. This is a goal we must strive toward together.

MAILING YEAR IN REVIEW

It's been a whole year since I was drafted from the floor of the elections assembly. Emotions have ranged from "What have I gotten myself into?" to "Can anyone think of a better job in AA?" The position of mailing secretary in Area 54 can sometimes be time-consuming. A typical mailing to 1250 groups includes a copy of our Recorder, several flyers, maybe a service piece, and usually a registration form for an upcoming conference. Six mailings are typical for a year. I will be stuffing this column into my seventh mailing sometime between Christmas and New Year's Day. During the last year, many friends and pigeons have helped out on 'Envelop Nights' at my house. We enjoy dinner and the fellowship of each others company while we handle approximately 8,000 pieces of paper [that's 8,000 opportunities to get a paper cut -YEAH!]. Then mailing labels are affixed to these now sealed envelops. The Area has a bulk mailing permit that saves us 40 cents on every piece of mail, provided we deliver our trays of envelops to the Akron post office in zip code numbered order. Having accurate addresses for our GSR's saves the Area a lot of money that can be spent more usefully.

Looking forward to 2004, our Committee is working hard to plan the Mini-Conference. Mark your calendars now for the Area 54 Mini-Conference, held this year once again at the Hudson Holiday Inn, April 2-4, 2004. The theme of the Mini-Conference and the 54th

General Service Conference is "Our Singleness of Purpose - The Cornerstone of AA." Look for the early-bird flyer in this mailing. Our state conference will focus on "Experience, Strength and Hope - The Changing Face of Sponsorship." Mark your calendars for July 23-25, 2004, in Hudson. We are fortunate to host the nation-wide Bridging the Gap Conference in Sandusky, September 10-12, 2004. Shut-ins

Mobile Groups; These are volunteers who take a regular A.A.meeting to those members who will be home bound or hospitalized for a long period of time. These members of our fellowship may consist of our Old Timers, and we should not let them disappear because they can no longer attend meetings. It may be a member who has a chronic illness or is bed ridden due to an accident. What ever the reason may be, they can no longer attend A.A. meetings for the love and fellowship they need. It would be ideal if we had Mobile Groups in each district. It could prove to be such rewarding 12 Step work.

Blind or Visually Impaired

This group of A.A. members primarily need volunteers who are willing to provide transportation to and from meetings and other A.A. events. It is also important that we be aware of the special needs the blind have in attending our meeting. The meeting should be set up exactly the same each week if at all possible. If anything has been moved, someone needs to guide him or her to their seats, restrooms, etc. If it is their first meeting, they should be informed of the literature that is available to them in braille or large print. It is also good to keep in mind, that some Alcoholics are embarrassed by the fact that they can't read or write. In order to be of help to them without singling them out, we can have the chair person point out that most of the A.A. literature is available on audio cassettes and cd.

Physical Disabilities

Some physically challenged A.A.'s can get to meetings. If your meeting is wheelchair accessible, make sure the room is arranged so that there is ample space for wheelchairs and walkers. They may need volunteers to drive them to and from meetings. Also, check that near by parking is available. If your meeting is wheelchair accessible, make sure that it is coded as such on your local meetings list.
