Hello Northeast Ohio Area 54

These first few months have been a learning time as well as busy. I will be serving on the Treatment Facilities Committee at the 55th General Service Conference in New York later this month. Jeff Y. and I attended the Delegates/ Past Delegates Conference in Detroit, Michigan. Mary B. Past Delegate Panel 39 rode with us and I was able to gain a lot of insight and information as well as a calming effect from her. Bob McK., Panel 47, Rob S., Panel 49 and Dan M., Panel 53 also attended and they too are a wealth of information. This was not the first time I was there, however I felt so humbled and overwhelmed when introduced as Panel 55 Delegate for Area 54 looking up and seeing them allowed me to continue and reminded me of all the lessons yet to learn.

Your Area Officers Jeff Y., Dan F., Rose M., Bill J., Bob D. and myself have traveled to Areas 53, 55 and 56 to attend their Mini-Conference

We will have held our 30th Annual Mini-Conference by the time you receive this mailing. You will have given me the best possible informed Area Conscience. In addition, you have had the experience of meeting and sharing with the 11 standing Committee Chairs. My hope is that a new understanding of the crucial role that is fulfilled by these Committees will prompt some to join them in carrying the AA message of HOPE.

The following are Area 54 Highlights that I will present as a first year Delegate at the 55 General Service Conference.

Area 54 consists of 20 Counties and over

10,000 square miles; the largest and smallest Geographic Counties in the State are located here. We are home to over 1450 registered Groups in 62 Districts, including a Spanish district at large, also 10 intergroups & district The Area also has a website, with a GSR fact file, scheduled events, districts & boundaries and how to reach any of the officers or committee chairs. Of the 11 standing committees 3 have Past Delegates as the Chairperson; The newest Committee is Group Services, we believe this is going to be a valuable tool not just for the Area but the Service structure as a whole, by informing and teaching about the Third Legacy we can only grow stronger. (We don't know what we don't know) The challenge remains to get and keep groups active as well as practicing the Seventh Tradition. Each of our six Area Officers serves as a liaison to two or more of the 11 Committees. We offer 3 workshops, Committee, DCM and GSR in addition to our 6 Area Assemblies, there is also an Area Open House Picnic and in November a dinner to express our Gratitude to the program, and these 2 move around to various Districts in the Area.

We are hosting our 30th Annual Mini-Conference based on the General Service Conference. It allows all AA members an opportunity to see the process at work using some of the actual Agenda items, more information leads to a better understanding. This also allows your Delegate to have an informed Area group conscience when they attend the Conference We also get to hear reports from our invited guests usually Past Delegates and the East Central Regional Trustee who covers 14 Delegate Areas in 5 states including the 4 in Ohio as well as a speaker from General Service Office. I feel so honored and grateful (a drunk like me) to serve Alcoholics Anonymous and Area 54 along side all the dedicated Committees, Officers and Past Officers. Thank you for my life

Area Officer Reports

Report on 32nd Annual Delegates and Past Delegates of the East Central Region Conference, February 11-13, 2005 – Southfield, MI

I accompanied Alice H. to the 32nd Annual Delegates and Past Delegates Conference this past weekend in Detroit. Past delegates in attendance from our Area were Dan M, Rob S, Bob McK, and Mary B.

Background materials in handbook format were passed out to each of the Panel 55 incoming delegates and their alternates. I learned that our first delegate in our area was Bill D (the "man on the bed" – AA Number 3). Our second delegate was Ethyl M, whose story "From Farm to City" appeared in the 2nd and 3rd editions of the Big Book. Friday evening included presentation of the area highlights from each of the eight incoming Panel 55 delegates and conference highlights from each of the region's six Panel 54 delegates. Saturday we heard reports from Eva S, and Dorothy M, our ECR trustee. Eva presented a report on the recent activities of all the GSO staffers.

CPC desk (Rick W) is coordinating 60 exhibits at professional conferences around the U.S. this year. Our website is receiving 60-75 inquiries from professionals every month.

PI desk (Gail S-R) is working on the 2004 Membership Survey in preparatio

2004 Membership Survey in preparation for approval at the 55th GSC. Our area was selected as one of the survey samples and late last year, I had the privilege of surveying two groups in my neighborhood. There has been a multitude of inquiries to Gail around the 2005 International Convention from the media. She will be staffing a press room at the convention, setting up interviews with Class A Trustees, issuing press releases, and briefing the press on our policy of anonymity at the level of press, radio, film and other electronic media. 2005 International Convention (Doug R) reports that over 25,000 AAs and Al-Anons have registered for Toronto from 70 countries, including for the first time, members from Cuba, China, and

Mongolia.

Literature desk (Mary D) with our newest staff member, Mary D, reports that Croatia has opened its first Central Office. A Latvian translation of the Big Book is at the printer. A translation in Zulu is in distribution.

Treatment Facilities and Loners
Internationalists Meeting (Irene K) reports
that three groups have registered from
coalition force military bases in Iraq.
Conference desk (Eva S) reports that this
year, delegates will have the option of
receiving the Conference agenda on CDROM. The full printed agenda is 493
pages long.

Introductions of the candidates for ECR Trustee and Trustee-at-Large U.S. were made by the delegates of their home areas. There are seven candidates for our regional Trusteeship and five candidates from ECR for the US At-Large position. Election of these trustees will occur at the 55th GSC in April. Our own Robert McK.(47/54) was introduced by Alice H and given two minutes to address the body. Bob reminded us that "Ours is not a business doing spiritual work, but rather [ours] is a spiritual entity which must, of needs, conduct some business."

Saturday evening, Eva S was the speaker after the banquet. She shared a wonderful combination of experience, strength and hope for all present.

The Ohio State Convention planning committee comprised of officers from Ohio's four delegate areas met over breakfast and reviewed plans for the 2005 State Convention to be held in Columbus, August 12-14, hosted by Area 53. Sunday morning was given over to a mock conference experience complete with committee recommendations, floor mikes and friendly amendments. I realized how well our own mini-conference mirrors this experience. Northeast Ohio will be hosting this conference in our Area in February 2007. As we learned from one of the delegates on Saturday,
