The 55th General Service Conference consisted of 136 voting members. 93 (68.4%) are Delegates from the U.S. and Canada. The Delegates constitute at least two -thirds of the voting members. 27 (19.9%) are Trustees (Non-Alcoholic, Class A - total 7 and Alcoholic, Class B – total 14), A.A. World Service Directors (3), and Grapevine Directors (3). 16 (11.2%) General Service Office and Grapevine Staff.

The average age of the Delegate this year was 54, the oldest being 68, the youngest 33. The average length of sobriety was 17 years, longest sobriety, 35 years and shortest sobriety, 8 years. Average length of service servant of 33 years and the shortest time in service, 7 years.

We were reminded to trust the group conscience of our committee, to trust the Conference process. That even with our Area conscience, feelings and opinions to put our own agendas aside and remember this is for AA as a whole.

Theme for 2006 General Service Conference "Sponsorship, Service and Self-Support in a

Changing World."

The workshop topic for the 2006 General Service Conference:

"Passing It On in a Changing World." Since returning from the 55th GSC I have given invited to give four Post Conference reports. The first was the day after I had returned home minus luggage, that went on to Houston for a visit, so minus all folders and information other than an Early Bird Box 459 and a couple of notes off we went Monday night to Celebrate Sobriety. Area Officer Reports

THE LITTLE AGENDA ITEM THAT COULD ... or a firsthand history of an alcoholic's idea and how we can all impact A.A. the world over.

An idea, suggestion or subject comes from A.A. members and sometimes friends outside A.A., and is first discussed by G.S.O. staff or A.A.W.S. and then forwarded to appropriate trustees committees (1. If concept is accepted a writer is assigned; 2. manuscript is reviewed). The matter is then referred to appropriate Conference committee which meets during General Service Conference week and makes a recommendation that goes in the committee report to the General Service Conference which. if approved after full floor discussion, becomes a Conference Advisory Action that becomes binding when approved to the General Service Board. Unedited manuscript goes to editor to copy edit and rewrite where necessary, implementing changes made by the staff and committee, then to production.

At the July 2003 East Central Regional Forum, Andy T., Area 53 delegate Panel 53, gave a presentation entitled, "Service Sponsorship: Guides were lively and numerous. He states, "Service sponsorship helps us understand a new language of GSR's, DCM's, minority opinions, and disagreeing without being disagreeable...We are not alone in our personal recovery, and through service sponsorship we are not alone in giving back to AA."

One response to his presentation was a comment from the floor wondering if AAWS had a service piece or pamphlet explaining this important aspect of AA service work. Area 54 members present that Conference Committee on Literature develop a weekend picked up on that question. On the way home from Columbus, Indiana they began thinking and talking about how to submit a formal request to the General Service Conference for such a piece. This article will give one member's eye view of how that process moved through the committee system and ultimately became part of a revised piece of Conference-approved literature.

Jeff Y., Area 54 registrar at the time, was intrigued by the idea of service sponsorship. He had heard the term used years before when he was active in Area 55 (NWOH). Andy T's presentation reminded him that just as we encourage newcomers Here is the text of the Trustee's Agenda Committee to AA to work the Steps with the guidance of a sponsor, so too, a service sponsor helps the newcomer in

service work to understand the interconnectedness and historical context of our Twelve Traditions. Twelve Concepts, Six Warranties and Three

Some AA's are fortunate to have a 'recovery'

sponsor who integrates 'unity' and 'service' into sponsorship; others less fortunate must seek out additional individuals when they are ready to explore AA service beyond the group level.

Jeff discussed these ideas with our delegate, Dan M., (54/53). Dan encouraged him to develop some background material based on Andy's talk and present it to the Area Assembly that fall. Andy graciously forwarded the original talking points that he used for his presentation, expressing how honored he felt to be the impetus for an agenda item.

A few emails around the area elicited comments from GSRs, DCMs, and other officers. The background material was made up of several emails, Andy's original text, and a formal request to develop a service piece or literature item addressed to the Trustee's Agenda Committee.

In late September, the delegate received a communication from GSO. The staffer gave us some feedback on the exact language of our agenda item request and pointed out some current literature which addressed service sponsorship. GSO was kind enough to email out a copy of the service material right away for our review. After looking this over, we agreed that the present literature on service sponsorship came up short and needed revision and amplification. GSO to AA's Future." Responses to Andy's presentation also asked us to reword our request more specifically - did we want a service piece that could be revised easily or did we want to pursue the more rigorous path of Conference-Approval? A lively discussion burned up the wires among the officers and the past delegates on the merits of each. In the end, the wisdom of the past delegates prevailed. In October 2003, the Area Assembly listened to a presentation of the item and voiced their approval to forward the agenda item request to the Conference Coordinator at GSO. The request was re-submitted to the Trustee's Agenda Committee requesting that the 2004 General Service separate pamphlet to address "service sponsorship".

> "The Area motion to create a pamphlet on service sponsorship was discussed at the Board Weekend in November. They tabled further discussion until the January Board Weekend. Consider request that the trustees' Literature Committee develop a Conference-approved pamphlet on "service sponsorship." [acting on a] Suggestion to develop pamphlet on "service sponsorship": The committee discussed and agreed to forward the suggestion that the trustees' Literature Committee consider the development of a Conference approved pamphlet on "service sponsorship" to the

2004 Conference Literature Committee.

The agenda of the 54th GSC Conference Committee on Literature included the following item:

Consider request the Trustees' Literature Committee develop a Conference-approved pamphlet on "service sponsorship."

At the 2004 GSC, the Conference Committee on Literature reviewed the current section on service sponsorship on page 28 in the pamphlet "Questions and Answers on Sponsorship" and reported back to the Conference the recommendation that

The trustees' Literature Committee broaden the section titled 'Service Sponsorship' on page 28 in the pamphlet "Questions and Answers on Sponsorship" to reflect current shared experience and present a revised draft to the 2005 Conference Literature Committee.

This became an Advisory Action of that year's Conference.

The 2005 Agenda for the Conference Committee on Literature included: E. Consider revised draft text for the section titled "Service Sponsorship" on page 28 in the pamphlet "Questions and Answers on Sponsorship."

The following recommendation was approved by the 55th General Service Conference and the General Service Board:

13. The addition of the following four paragraphs to the current section titled "Service Sponsorship" in the pamphlet "Questions and Answers on Sponsorship" be approved with minor revisions to the current pamphlet text suggested by the committee:

a)...A.A. service is anything whatever that helps us to reach a fellow sufferer ranging all the way from the Twelfth Step itself to a ten-cent phone call and a cup of coffee, and to A.A.'s General Service Office for national and international action. The sum total of all these services is our Third Legacy of Service - The AA Service Manual/Twelve Concepts for World Service, page S1.

b)A service sponsor is usually someone who is knowledgeable in A.A. history and has a strong background in the service

We were also able to get him a Big Book to take back on the road. We were sure to tell him to pass it on if he felt he didn't fit the description of an Alcoholic.

The gentleman and I exchanged e-mail addresses and promised to keep in touch. I heard from him about two weeks later and he reports that he is doing fine and he was glad to have the literature and doesn't feel the need to pass it on... yet.

structure. The A.A. member is introduced to a new language: GSR, DCM, area assembly, minority opinion. They will become familiar with the Traditions, Concepts and General Warranties, as well as the A.A. Service Manual/Twelve Concepts for World Service, A.A. Comes of Age and other A.A. literature.

- c)Co-founder Dr. Bob said, "I spend a great deal of time passing on what I learned to others who want and need it badly. I do it for four reasons: 1)Sense of duty.
- 2)It is a pleasure.
- 3)Because in so doing I am paying my debt to the man who took time to pass it on to me.
- 4)Because every time I do it I take out a little more insurance for myself against a possible slip.
- d)The basis of all sponsorship is to lead by example. Service sponsors can impart to their sponsees the pleasure of involvement in the work of Alcoholics Anonymous. This is best done by stressing the spiritual nature of service work and by pointing out the usefulness of simple footwork and faith
