

Cooperation With the Professional Community and Special Needs Committees

Review contents of C.P.C. Kit and Workbook. No recommendation Reviewed with appreciation. Review contents of Special Needs Workbook No recommendation Reviewed with appreciation.

Discuss specific possible uses of the A.A. Grapevine and La Viña in C.P.C. (and Special Needs) endeavors.

<u>Additional considerations</u>: The Committee discussed ways to utilize GV and suggested placing old issues in professional offices and places they serve, i.e. doctors, barbershops, recovery houses, rescue missions, DUI schools, VA hospitals, teen pregnancies centers, judges and drug court professions, educators and other.

Consider request to develop a new Special Needs recovery pamphlet for newcomers or prospective members. *Recommend:* that the Publications Department develop a new Special Needs recovery pamphlet for newcomers or prospective members, and that a draft or progress report be considered by the trustees' and the Conference Committees next year. After no debate, the floor voted 88-4 to approve this recommendation.

Consider request "to develop a generic A.A. poster or posters for places such as hospitals, places of employment, doctors' offices, etc." The committee made no recommendation.

Consider request to publish a book of stories from members living in remote communities... *Recommend:* that the Publications Department develop draft materials of stories from members living in remote communities, or progress report, to be considered by the trustees' and the Conference Committees next year. **After no debate the recommendation** passes 89-3.

Corrections Committee

Review contents of Corrections Kit and Workbook.

Additional considerations: Conversion of the video to DVD and update "Inmate to Inmate" literature

Consider updating the pamphlet "It Sure Beats Sitting in a Cell." Recommend: that the pamphlet "It Sure Beats Sitting in a Cell" be updated, and that a draft revision or progress report be returned to the trustees' and Conference Committees next year. After no debate the recommendation passes 87-5

Discuss issues that may be involved in A.A. members' complying with the rules of correctional facilities, such as signing "sponsorship agreements" or legally binding documents. **Additional considerations** In favor of AA members complying with the rules of correctional facilities but adding literature to explain the responsibility of signing legally binding documents or sponsorship agreements

Finance Committee

Review material submitted from the Fellowship concerning the 2008 Conference Advisory Action "the trustees' Finance and Budgetary Committee gather input from the Fellowship on the benefits and liabilities, both spiritual and practical of fully funding G.S.O. Services to the Fellowship (G.S.O. functional expenses) by the voluntary contributions of A.A. members and groups." **Additional Considerations** We feel that self-support should be a goal. We feel that one method would be to emphasis the Birthday Plan that we ask GSO to give a separate report of Birthday Plan contributions by area to the delegates.

Discuss request to produce a Seventh Tradition poster. Recommend that the Publications Department develop a draft poster on the Seventh Tradition, and that said draft or progress report, be considered by the trustees' and the Conference Committees next year. After lengthy debate, the recommendation failed. Additional considerations -- color; illustrations; and creativity be considered.

Discuss other aspects of self-support: No discussion

Grapevine Committee

Review contents of A.A. Grapevine and La Viña Workbook. No recommendation

Consider request that "the 2007 Conference Advisory Action recommending that 'the Grapevine and La Viña include a section on the medical, legal, and social aspects of alcoholism, with an appropriate disclaimer' be rescinded." *Recommend* that the current section on the medical, legal and social aspects of alcoholism, in the AA Grapevine and La Viña be removed. **After lengthy debate the recommendation fails.**

Consider request that the following 2004 Conference Advisory Action be rescinded:

"To allow the widest distribution of the A.A. Grapevine and La Viña to all purchasers, while guarding against affiliations with any outside enterprise, a) subscriptions to the A.A. Grapevine and La Viña magazines be issued only by A.A. Grapevine, Inc., or by A.A. trusted servants directly; and b) the A.A. Grapevine, Inc., adopt standardized sales practices and pricing structures for all purchasers. Note: This recommendation is to clarify the 1993 Advisory Action stating that the Grapevine Corporate Board not actively pursue the placement of Grapevine materials for resale in commercial (non-A.A.) outlets."

Additional considerations The Grapevine board to investigate alternative printing practices including material to minimize cost.

Literature Committee

Consider request that the pamphlet "Questions and Answers on Sponsorship" be reviewed toward eliminating or revising outmoded ethnic, cultural and vocational references.

Recommend that the Publications Department review the pamphlet "Questions and Answers on Sponsorship" toward eliminating or revising outmoded ethnic, cultural and vocational references, and that

revision or progress report be returned to the trustees and Conference Committees next year and that the publications department review all other pamphlets for similar outmoded language as they are reviewed. A request was made to remove the ",and..." part of the recommendation as a friendly amendment. The committee decided not to accept the amendment. After some debate the recommendation was approved.

Consider request to add a sentence to the pamphlet "A Newcomer Asks" that encourages newcomers to obtain and study the Big Book, Alcoholics Anonymous.

Recommend that a sentence be added to the pamphlet "A Newcomer Asks" that encourages newcomers to obtain and begin to study the Big Book, Alcoholics Anonymous, and that a draft revision or progress report be returned to the trustees' and Conference Committees next year. After little debate the recommendation passed.

Discuss whether there is a need to develop Conference-approved literature that focuses on the topics of spirituality, and agnostics or atheists/nonbelievers in A.A.

Recommend that there is a need to develop Conference-approved literature that focuses on the topics of spirituality, and agnostics or atheists/nonbelievers in A.A., and that a draft or progress report be returned to the trustees' and Conference Committees next year. After some debate the recommendation failed 56-29.

Consider request to develop a second volume of Daily Reflections. No recommendation

Consider request to develop a video on the General Service Representative (G.S.R.). No recommendation

Public Information Committee #1

Consider request to add the text "Provide initial motivation" to the section "What A.A. does NOT do" in the pamphlet "A.A. at a Glance."

Recommend that the text "Provide initial motivation" be added to the section "What A.A. does NOT do" in the pamphlet "A.A. at a Glance."

After no debate the recommendation passed.

Review updated text and graphics of the pamphlet "A Message to Teenagers...," which utilizes selected text and graphics from the current "Too Young?" pamphlet.

Recommend that the updated text and graphics of the pamphlet "A Message to Teenagers...," which utilizes selected text and graphics from the current "Too Young?" pamphlet be approved, and that the Publications Department will make the necessary changes when current stock is depleted.

After no debate the recommendation passed.

Public Service Announcements (P.S.A.s): Review current television P.S.A.s for relevance and usefulness. As an **additional consideration**, the committee felt that "What It Is Like" be updated with recommendations

listed by the trustees' PI Committee.

Public Information Committee #2

Consider draft 2010 Alcoholics Anonymous Membership Survey Questionnaire.

Recommend that the draft 2010 Alcoholics Anonymous Membership Survey Questionnaire be approved.

After little debate the recommendation passed.

Consider the need to clarify the importance of not breaking the anonymity of living A.A. members in memorial announcements when A.A. members when one of our Fellowship dies. *Recommend* the need to clarify the importance of not breaking the anonymity of living A.A. members in memorial announcements when one of our Fellowship dies by changing the Understanding Anonymity pamphlet. **After some debate the recommendation passed.**


After no debate the recommendation passed.

General Service: "What it is and My Experience"

A talk from this year's Northeast Ohio Mini-Conference...

Hello everybody, my name is Howard L. and I am an alcoholic. It is my pleasure and privilege to be serving Alcoholics Anonymous as the Southeast Regional Trustee on the General Service Board. Before I start on tonight's topic, I bring you greetings from Bob M., your Regional Trustee. As you probably know, Bob had a conflict this weekend and he was not able to be here. He sends his regrets and he is sorry he could not be here. I, on the other hand, am not sorry that Bob could not be here because that allows me to be here and I am really happy to be in Area 54!

I have been thinking about this topic and I would like to start by saying that to me, there are two types of service: Service Work and General Service. What are these two and what is the difference?

Service work is, in large part, the service work that we do in our home group and maybe a little at the district level. It is things like making coffee, setting up chairs, leading the meeting . . . things like that. These are the things that make Alcoholics Anonymous work.

General Service is similar, though it takes a longer view. General Service is taking A.A. beyond the reach of our home group. General Service is doing our part to make sure that Alcoholics Anonymous is there, wherever there is an alcoholic who reaches out for help. This is how we take responsibility for A.A., as is indicated in Concept I. General Service is what we do in the Districts, Areas and the General Service Conference to reach out beyond what we can do in our local group.

Which of these is more important? Neither. Both. Why? It is like either taking a bath or a shower. It is two different ways to accomplish the same thing. Regardless of whether you bath or shower, the purpose is to get clean and that is what happens. Whether you are doing Service Work or General Service, the purpose is the same – to carry the message of Alcoholics Anonymous and no matter which way you go, it works.

What is my part in this as a Regional Trustee? Like so many of our jobs in A.A., the Regional Trustee is a two-part job. First, I am a Trustee on the General Service Board of Alcoholics Anonymous. Here I am legal and financial responsibility to protect and oversee our money and our message as it is presented in our literature.

Then there is my Regional Trustee responsibility. To define the Southeast Region, if you draw a line across the top of Virginia, West Virginia and Kentucky, all the way

over to the river and come down south to the Gulf of Mexico, grab Louisiana, go to the end of Florida and get Puerto Rico, as well. That is the Southeast Region. What do I do? Well to start with, I do not "represent" the Southeast Region, like a Senator or Representative. I do not "lobby" to get things for the Region. I mean, what would I try to get? More drunks for the Southeast? No, but I do serve the Fellowship and I travel and visit within the Region. I do what I am doing here in Area 54 this weekend. I visit and share with you what is going on, what you think, what you want to say. You could say that I, and all of the Regional Trustees, are the face of the General Service Board to the members of Alcoholics Anonymous. We (the Regionals) get to hear what we (the members) think about what we (the board) are doing and what we (the board) should be doing. It is the best of the service jobs because I get to spend more time with "us" that any other Trustee position except maybe the Chair of the General Service Board because he or she travels to all of the Regional Forums and to a lot of functions on behalf of the board.

So there you have it, what I think General Service is and a quick description of the service job of a Regional Trustee. Again, I am truly grateful and happy for the opportunity to be here in Area 54 this weekend. If there is anything you want to say, ask about, or share, I am here all weekend and that is why I am here – to hear what you have to say.
