### A Word From Our Delegate

In September I attended the National Alcoholics Anonymous Archives Workshop which was held at the Double Tree in Independence, Ohio. What an awesome learning experience. "The primary purpose of those involved in archives work is to collect and preserve the message of Alcoholics Anonymous." Bill says "We are trying to build up extensive records which will be of value to a future historian...It is highly important that the factual material be placed in our files in such a way that there can be no substantial distortion..." I am grateful that our GSO, Area, Districts, Groups and Intergroup/ Central offices have people who have dedicated themselves to this great responsibility. I encourage groups to write and/or update their histories to be included in AA history.

Recently I attended the East Central Regional Forum, which was held in Milwaukee, Wisconsin. There were Presentations, Workshops, Ask-It-Basket and General Sharing Sessions. Regional Forums provide an opportunity for communication with some members of the General Service Board, A.A. World Services, Inc., A.A. Grapevine Corporate Board, G.S.O. and Grapevine Staff. It is an opportunity to communicate/question both hired hands and trusted servants of A.A.

I was asked to be moderator for a workshop and the topic was "Singleness of Purpose." One question for discussion was "Why all this insistence on Singleness of Purpose?" ### <u>WHY SHOULD I ATTEND THE NORTHEAST OHIO MINI</u> -CONFERENCE?

Here are just a few good reasons why everyone, whether you are involved in General Service work or not, is encouraged to attend the Northeast Ohio Mini-Conference.

### A reprint from the March 1961 issue of Area 74's newsletter, "Now and Then":

John Donne, an old English poet, once wrote that no man is an island, separate and independent from the rest of the world, but that all of us are part of the same large body of mankind. He went on to say that if something happened to any one of us, all of us are in some way affected. And if someone dies — "Do not ask for whom the bell tolls. It tolls for thee."

The same is true for us in AA. Sometimes we think that our own little AA group is the only thing that matters, and is all we need to keep our sobriety. This is not true. No group could exist for very long without the help and guidance and services it receives from the whole world-wide structure of Alcoholics Anonymous. AA is like a vine with one root and many branches. If blight attacks one part of the vine, or if the root is cut, the whole thing dies. Each part is dependent on every other part.

That is why it is important for every group in our Area to be active in Area affairs. That is the only way we can be active, and a healthy part of AA as a whole. It is the only way your group or mine can avoid the likelihood of ending up as a dead and withered leaf on the vine.

## **General Sharing Session, August 2015 General Service Board Meeting, NYC**

The topic of the third quarterly General Sharing Session was 'A.A.'s Primary Purpose: Reaching the Alcoholic Who Still Suffers." Bill F., regional trustee, and Bill N., general service trustee, presented on the topic. John Fromson, (non-alcoholic) Class A trustee, chaired the session.

Bill F. shared on the subtopic, "What more could we do?'.' and noted that he has often asked himself, "What more can I do to help?" He added that, the Big Book, Alcoholics Anonymous, recommends that we "find another alcoholic to work with," but that is not our challenge as a board of trusted servants. Bill is skeptical of the suggestion that A.A. growth has leveled off. In his view, A.A. is such that a survey is impossible or improbable at best. He added that Tradition Five says our primary purpose is "carrying the message to the alcoholic who still suffers: Simple and to the point.

As an A.A. group, his group does not stray from their primary purpose because, he said, we follow the other eleven Traditions to the best of our abilities and the rewards are great. Bill described how each Tradition plays a role in

the group and suggested that the Twelve Traditions are interwoven like a strong basket. Its weave adds strength as at some points there is a double weave. This underpinning of many reeds adds to its sturdy nature. Bill said he has no answer to the question, "what more could we do?" But, he noted, we are not alone in asking ourselves that question. Many organizations are doing exactly the same. What he discovered is that there are plenty of alcoholics to carry the message to.

Bill N. shared on the subtopic. 'Are our literature and communication tools effective in helping groups and members reach the alcoholic who still suffers?" Bill started by saying that it is possible to answer such a yes-no question with a ves-no answer. He noted that this is a very sensitive subject inside A.A. and he welcomed both feedback and criticism. He cited a talk Bill W. gave in Toronto in 1965 on a panel entitled, "Our Responsibility to A.A.'s Future': In this talk. Bill W. said, "Our first concern should be for those sufferers of alcoholism that we are still unable to reach." Bill W. was concerned about one

thing, and that was how A.A. could reach those it was not reaching yet.

Bill expressed great concern about the diversity of our membership compared to the make-up of the population of the United States and Canada. In his view, outside issues have affected our effectiveness, and our great literature has been the great equalizer. In his experience, there was a time when he was in favor of burning all literature except the Big Book. He believed that this literature made people feel different than others or unique. Today, he feels that the Big Book is for people in A.A., and the other literature for those thinking about joining A.A. or declaring themselves a member- two very different purposes.

Bill believes A.A. that we should carefully evaluate how a particular communication method or technology will help us carry our life-saving message, making sure that any new technology we embrace falls within our great 12 Traditions.

Bill added, in closing, that the Internet and other communication platforms have become

the primary ways people communicate, but these platforms are also sources people turn to for information. He remembered a Class A trustee say a few years ago "A.A. has a choice to make, does it wish to be relevant in today's society? And if it does it better be in the places where people today look for help."

After the presentations, John Fromson, the moderator, invited comments and sharing on the topic. An appointed committee member commented that when we don't reach out or welcome people, we lose the stories that will attract still other alcoholics. Her group has a hospitality break for members to go and talk to someone new - not talk to their friends.

A director spoke about a Regional Forum workshop on anonymity breaks on social media and the internet and asked "what opportunity are we missing when we don't have a presence on social media?" He feels there is misinformation about A.A. on social media, because we don't have a presence there. An appointed committee member talked about his contact with the committees for the Interna-

tional Conference of Young People in A.A. (ICYPAA) and the Miami YPAA who are doing A.A. work on social media, but are having trouble coming to a group conscience about whether to continue. One reason they cited for the lack of group conscience was fear due to recommendations from the General Service Conference regarding social media. A trustee followed up by asking how we can insure that AA.org comes up in search engines.

Another trustee referred to a change in attendance an annual district event after a "secret" Facebook page was created for it. Attendance was usually about 50, and it jumped to 600. An appointed committee member expressed concern that sometimes A.A. moves so slowly that we miss good opportunities, sometimes procedure slows us, sometimes fear slows us. But we also should remember that not all alcoholics have online access-we still need paper.

An appointed committee member mentioned that the ethnic diversity in A.A. does not mirror the local community and noted the need for literature and A.A. contacts for newcomers who speak other languages. A director noted that A.A. wants to welcome every alcoholic, but expressed concern that some members negatively judge newcomers who are alcoholics but also used drugs, and that too much focus on one Tradition might be blocking us from following another.

A trustee told the story of someone he was sponsoring who had gone back to drinking, and how she felt rejected when she returned to A.A. He encouraged us to do all we can to help a member who has strayed from the fold. John, the moderator, thanked the participants and closed the General Sharing Session with the Serenity Prayer.

## SPIRITUALITY – HOW AND WHY

Just before I came into the Program, I became a disgusting, crying drunk. I'd call different family members, to share that misery. Since they didn't have caller I.D. then, some unfortunate family member had to pretend to listen to me tell that same story about my abusive childhood, awful marriages and so on. One night a sister told me to talk to God the way I was talking to her. I was drunk but I do remember asking Him, "Why was I born in the first place?" What I didn't know. I was really asking God, "What is your will for me?" A few days later, she said I called to tell her I decided to change my life. I must have been in a blackout; because that was 30 years ago and I still don't remember having said that. I went to a Treatment Center after that.

Walking into my first A.A. Meeting, I saw something on the faces of the members and wanted what they had. Combined with all that happened up to that point, now I can label what I felt. It was my first spiritual experience. I really don't know if I would have gone back out without that spiritual experience; but I do know, I stayed because of it. I started praying, on a semi-regular basis, at this point.

It was during my second year when a man in the program gave me a meditation tape. I was learning to relax and clear my mind. I would read

the thought and meditation for that day and meditate on it. I was waiting for God to reveal some hidden message in the reading. I didn't realize I was internalizing the message and growing in character. At my sponsor's house one day, while waiting for her to return, I picked up a pamphlet from her table. The title read, "Why do you keep meditating on things your eyes can see? There are ghosts in your house".

I became uncomfortable while reading the article and decided not to read a passage before I meditated. Sometime later, I started to experience flashbacks. With help from our outside friends, prayer and daily meditation and fellowshipping with my A.A. family, slowly a terrible event was revealed that many of my character defects were related. I believe then, as I believe now, the God of my understanding removed my last excuse for drinking. After six years, that event became important only because it could be used to help someone else. At this point, I knew God wanted me to be sober and He was returning me to sanity. Forming a relationship with the God of my understanding became paramount in my life. That power returned that I had chased away with alcohol.

For the first ten years of my sobriety, I attended a weekly progressive Step Meeting. I prayed and mediated a lot. In retrospect, I was open and willing, to apply the Twelve Steps in my life. I realized that God worked through people. I listened to others. I heard people say things I needed to hear. About eleven years of sobriety, I asked my sponsor why a member hadn't asked me to sponsor them. She said it was because I was too honest. So, I was rigorously honest. I loved going to meetings. I knew I was growing spiritually. It had to be coming from all of the things I was doing.

There were just a few small problems, however. Just because I walked through the doors of Alcoholics Anonymous didn't mean my episodes of depression and feelings of persecution magically disappeared. The "committee" didn't permanently adjourn. Emotionally I was so damaged. I found refuge and comfort with my relationship with God and talking to my sponsor. I believe that's why I stayed sober.

As the years progressed, I realized much of my spiritual growth came from every day life experiences. This demanded rigorous honesty, openness and willingness. The word "rigorous" means meticulous or painstaking. I have to say more than, "I told a Lie." I had to tell every detail connected to the lie, including my motive. I had to remain open to the possibility that what I thought to be truth was not the truth. I must be willing to act on this new truth and to sincerely thank the person who helped me to grow, regardless of how that person revealed that truth.

Spiritual growth was also obtained through adversity. I gained a

great deal during a time in sobriety that I wanted to give up. I didn't want to drink. I wanted to give up on life. I heard spoken to me, "God's love is all sufficient." I didn't get overjoyed, but I didn't want to give up. It was a period of time which lasted over five years. Throughout that time, God sent profound blessings. My heart and eyes had to remain open to those blessings. At this stage of my spirituality, I communed with God. I was sick and couldn't go to meetings for two years; but I stayed in fit spiritual condition. Thanks to His undeserved kindness. That's how I stayed sober. If not for the fellowship, I would have not met the God of my own understanding and not grown spiritually to where I needed to be, to get through that awful period of time.

In the last eight years, I have served A.A. at the Area level in some capacity. God pushed me out there. Although I really needed it, I was reluctant at first. Now that we understood each other, I knew He was sending me a life boat and it was to my benefit to get in. Every time I get distracted, God reminds me that I asked, "What is your will for me?" So I knew I was going on another adventure.

I trust my God today. Even with my personality flaws, I'm free from the bondage of self. I don't fear people anymore. I know a power greater than myself did for me what I could not do for myself. I live in a spiritual realm.

Throughout this presentation, I have told you how I think I grew spir-

itually. As I was preparing this, I kept asking myself, did I really put that much effort into it? God may have done something tricky we don't know about. Anyway, if you don't put anything in, you won't get anything out. This I know. I also included why we should grow spiritually. Many of you knew that already.

Fancy words and trying to impart profound wisdom isn't necessary. It is our presence that inspires people. It's what many new people see upon entering their first A.A. meeting. They look at our faces and want what we have.

## Concept 3—The Right of Decision

I confess, I have trouble sitting through lectures, regardless of the topic presented and without regard to who's presenting it. Like many alcoholics, I just don't like being "talked down to", or lectured for that matter. But, I DO love a good story. And on this preference, much of AA's success has come to pass. So what story can I tell to explain Concept III, the "Right of Decision"?

At first, I tried to understand the Concepts by reading them, which didn't work at all. Yes, I "learned" them. meaning that I could repeat what they said, and much of how they were explained in the service manual. However, the understanding I sought was still missing. In other words, I had no story to tell that would let me explain to you (and to those who elected me) what exactly it was that I had learned. It makes no difference whether I'm discussing the Concepts, or the Steps, or the Traditions: without action there is no experience; and without experience there is no understanding. Understanding, at least for me, never arrives before I start taking action. Let me give you an example.

When I attended my first General Service Conference, I arrived with an understanding of how Area 19 felt about most of the Agenda items. I gained that understanding as a byproduct of Area 19's Delegate's Preconference Forum and discussion of agenda items. I had notes on my laptop to which I could refer as those items came up at the conference and this proved useful, but not always as originally intended. After I returned from GSC, I was asked by one of the more involved attendees at the Preconference Forum, "So what happened with the 12 & 12 & 12?" Area 19 was very much in favor of having the Steps, Traditions and Concepts brought together in a single volume. But, I had to tell this member not only that it didn't pass, but also that I had voted against it. "Why would you do that? I remember that we wanted that single volume. We voted yes, you were supposed to vote yes. What

happened?" was the understandable response to my exercise of the Right of Decision.

I had to explain that when the agenda item came up, I had planned to vote yes, not just because it was the sentiment expressed at the Forum but also because I agreed with that sentiment. But then the discussion started at GSC. Initially, the Delegates going up to the mic expressed the same thoughts and opinions that Area 19 had expressed. And I still fully intended to vote yes and believed that we had thoroughly discussed this item.

Then came the first voice to speak against "us". I remember thinking just that- he is against "us". I listened to what he was saying; I had no choice, how else could I find the flaw in his thinking? But as he proceeded, I found myself agreeing with his points as well as his reasoning. I'm condensing his objections here, but essentially, his argument was based on an analogy with the three legacies: 1-The 12 Steps stand alone as the foundation of our first Legacy-Recovery; 2-The 12 Traditions stand alone as the foundation of our second Legacy-Unity; 3- But, and this is a big "but", the 12 Concepts do not stand alone as the foundation of our third Legacy of Service. While the Concepts ARE vital to Service, many AA members perform 12 step service work without reference to, or, more often than many of "us" would like to admit, even knowledge of, their very existence. By the time I grasped this argument, the estimated cost of \$150,000° for printing and manufacture served only to confirm what had become obvious to me and many others. As a result, I felt I had no other option but to change my vote. With this experience, the idea that as Delegate I represent the whole of Alcoholics Anonymous, and not just Area 19, came into much sharper focus.

Trust is earned. Area 19 believed they could trust me to vote the way they wanted me to vote based on the information and discussion we had at our Preconference Forum. However, when I told them I had changed my vote I could sense their disappointment, if not their outright disapproval. But, when I explained the new information I had received, and the more thoroughly informed discussion that took place at the Conference, they supported my actions, and, by inference, my judgment. I earned their Trust and as a consequence, I felt more a "Trusted Servant", than merely a servant.

As Delegate I am not the only one that has "The Right of Decision". The Third Concept tells me that "insuring their effective leadership, it is here suggested that we endow each of these elements of world service with a traditional "Right of Decision". "Insuring their effective leadership" reminds me that I have to remember how easy it is to "trust" when I get what I want. When a committee of which I am not a part, makes a decision with which I do not agree, am I able to "trust" that, based on all the information available to them, they made the

best decision for Alcoholics Anonymous? Am I able to accept that I am but a small piece of a great experience, spiritual in nature?

I can think of no better conclusion to this presentation than to end with the words of Bill Wilson as written in our service manual: Our entire AA Program rests squarely upon the principle of mutual trust. We trust GOD, we trust AA, and we trust each other. Therefore, we cannot do less, than trust our leaders in service. The Right of Decision we offer them is not only the practical means by which they may act and lead effectively, but it is also the symbol of our implicit confidence.
