
FROM THE EDITOR

Service In the Midst of a Pandemic: Fear Not.

We of Alcoholics Anonymous had to take a close look at our fears when we did our 4th Step. According to the Big Book, we should have "reviewed our fears thoroughly." (B.B. p. 68) Early in my recovery a long-timer gave me another way to look at it. He said there was no difference between resentment, anger and fear most of the time. Each one was all about me: resentment – I did not get my way in the past; anger – I'm not getting my way in the present; and, fear – I might not get my way in the future. He was correct. Fear is all about what might happen. Even when we find ourselves in the midst of COVID-19, fear is still nothing more than thoughts of the future.

I have also heard many people claim that there are "good" fears and "bad" fears. In my view, that is misleading - almost as misleading as those (especially among mental health professionals) who claim that some "types" of selfishness are "good" things. The problem centers around choice of words. Am I afraid to put my hand in a burning fire? No! I know what will happen if I put my hand in a burning fire, regardless of my expectations. Some would say "that's just common sense." But someone once said to me, "Common sense ain't so common!" Caution, not fear! Some of our religious fellows say, "Fear the Lord," or "fear God." Really? Am I afraid of God? The Hebrew word rendered "fear," from the source of many who have that belief is הוא "לְּצָּה transliterated "yirah." A better English rendering is probably "respect," or "to hold in awe" but that's a whole other conversation.

On October 11, 1918, the headline of *Variety* read, "*Epidemic Shows No Signs of Immediate Abatement.*" The picture below was taken in January 1920. It shows a field hospital on Long Island, NY.



The picture below was taken on March 31, 2020.



It shows a field hospital in the middle of Central Park, NY, standing at the ready. Perhaps as a nation we have learned not to regret the past nor shut the door on it. As members of AA we know a little about that. We also know if we ask God "to remove our fear and direct our attention to what He would have us be, [a]t once, we commence to outgrow fear." (B.B. pg. 68)

Language matters, and if I speak the "language of the heart" (love) I will not act or fail to act out of some form of fear. Rather, I will serve to the fullest of my capabilities exercising caution and respect - not selfishness and self-centeredness. When I cancel a meeting or move it online or when I make a phone call instead of a person-toperson visit during a pandemic, whether it be H1N1, COVID-19, or whatever comes next, I am still serving. But I have respect for the seriousness of the disease, and I act – or not – out of caution. Being of maximum service is fluid. Sometimes the maximum level that I am able to serve is taking your phone call or leading your Zoom meeting. If you ask me to come over, well, maybe not right now! But rest assured, "We shall be with you in the Fellowship of the Spirit... May God bless you and keep you – until then."

It used to be held in Perrysburg but the hotel it was held at has been sold so this year it was held at First United Methodist Church. It was held on Friday evening and all-day Saturday. The Friday session started with opening remarks By Jim S. Area 55 Delegate. There were Area highlights five minutes each for 2nd year delegates Stephen S. from Area 53 and our delegate Shyrl B. Area 54. Two-minute reports were given by Jim S. Area 55 and Nancy F. Area 56, followed by a GSO report given by Jeff W. who serves on the group services position. FROM THE CLEVELAND DISTRICT OFFICE...

The Cleveland District Office has received a number of calls asking us what our stance/suggestions are regarding meetings and the COVID-19 virus. In accordance with our 10th tradition "Alcoholics Anonymous has no opinion on outside issues, hence the A.A. name ought never be drawn into public controversy".

Each group is autonomous and can decide what protocols they want at their meeting through a group conscience. The Group should announce what the group protocols are before the meeting starts so there is no confusion about hand holding at the end of the meeting.

Since there is no vaccine to prevent the COVID-19 virus, each member may want to think about the following suggestions:

Here are everyday actions to help prevent the spread of respiratory viruses in general, such as colds and the flu:

- Wash your hands often with soap and water for at least 20 seconds. If soap and water are not available, use an alcohol-based hand sanitizer
- Avoid touching your eyes, nose and mouth with unwashed hands
- Don't share food, beverages or smoking devices with others
- Avoid close contact with people who are sick
- Avoid shaking hands—try a fist bump instead
- Stay home when sick
- Clean and disinfect frequently touched objects and surfaces

Cough or sneeze into your elbow or sleeve or cover coughs or sneezes with a tissue and throw the tissue directly into the trash

A MESSAGE FROM THE GENERAL SERVICE OFFICE

The General Service Office (G.S.O.) of Alcoholics Anonymous for the U.S./ Canada functions as a repository for A.A. members and groups who are looking for shared experience from the A.A. Fellowship. As the global situation related to Coronavirus (COVID-19) continues to develop, G.S.O. is fully committed to its role as an important resource center to help navigate this unprecedented public health emergency.

It is important to note, G.S.O. is not an authoritative body over A.A. groups, nor does it initiate rules or directives, as each A.A. group and entity is autonomous and decisions are made through an individual group conscience. Providing guidance on health issues is outside the scope of the A.A. sharing that G.S.O. offers. For anyone experiencing health and safety questions, it is suggested they contact national, state/provincial and local health authorities for appropriate information.

However, in response to the global outbreak, the office does have some general experience regarding how some A.A. groups and members have begun addressing this issue. Many are following "social distancing" guidelines established by local, state/provincial and federal officials, while at the same time maintaining their focus on recovery and facilitating digital A.A. meetings.

By attending digital meetings, group members can focus on A.A.'s primary purpose: to carry its message of recovery to the alcoholic who still suffers. Many groups have alerted local A.A. offices or hotlines if they are temporarily not meeting in their regular physical space. Some groups have shared that they are utilizing digital platforms such as Zoom, Google Hangouts, or conducting conference calls.

A.A. groups and members are also creating contact lists, keeping in touch by phone, email or social media. Many local A.A. central/intergroup offices and area service structures have added information to their websites about how to change a meeting format from "in-person" to a digital platform.

A.A. in the digital age has certainly taken on a new meaning in these challenging times, reminding its members and those searching for help that A.A. is not just a "place," but exists in the hearts, minds and help offered.

A WORD FROM AKRON



Founders' Day 2020 Has Been Cancelled

Akron, Ohio - Birthplace of A.A.

Due to health concerns for our attendees and volunteers, the Founders' Day Committee has made the difficult decision to cancel this year's Founders' Day Celebration. Everyone who has pre-registered will be receiving a full refund. We will post more details as they become available.

...and now for a legal opinion:

We alcoholics are pretty crafty people. We will do whatever we can to GET OUR WAY. We will find or make-up excuses to not follow rules and regulations recommended by medical professionals. We've been doing it for years. We've heard, "Well, the Governor said 10 people is OK, and my group only has 8." Or, "Aren't we an essential service?"

Technically, a legal argument could be made that some facilities that hold AA meetings fit the definition of "Human Services Operations," which are exempt from Ohio's Stay-at-Home Order. Specifically, the Order provides "individuals may leave their residences to work for or obtain service from any Human Services Operation. Those Operations include both private, federal, state and VA funded "Operations," both profit and non-profit based. The Order also defines Human Services Operations as including "residential settings for ... substance abuse disorders..." So, for example, some have argued that going to a meeting at the VA Hospital or at a treatment center or even at a church (they are exempt too) is legally permitted.



Stop!!!! Wrong!!!! AA is independent and does not own or operate any such facility. We are self-supporting through our own contributions. We are NOT affiliated with such entities. Therefore, we are not an "operation" of such a facility or entity. The entities, who may themselves be renting and may be made up entirely of AA members, such as a club (you know who you are), simply provide space in their respective facilities to accommodate AA, and we ought to be paying rent or providing some other form of gratitude.

And, it isn't about ten people either. As a prominent church leader in our state has said, "even where two people gather and do not practice 'social distancing' they are potentially exposing each other, and therefore exposing a multitude of others." Remember, the virus can be spread by people who have no symptoms and don't even know they have it. The Coronavirus does not have a twelve-step program in its life cycle.

So, let's just "keep it simple": STAY AT HOME!!!!
