### A Word From Our Delegate

With all of you, we embark on this journey of 2021 and Panel 71 together. When I became a GSR, at my first Dual District meeting, Alice H. told me that I was needed. I told her when I thought I could do the work I would stand up. What a journey from then to now.



I am rotating in as your Delegate, just as our East Central Regional Trustee, Mark E. is rotating out. He has served us well for four years. Mark E. shared the latest news from our General Service Office (GSO). I want to pass it on to you.

As some of you know, GSO had to draw from our Prudent Reserves additions monies. The draw was for \$1.5 million. As I understand it, this was to cover, in part, the cost of the Voluntary Retirement and Incentive Plan (VRIP). Twenty GSO staff employees chose to accept this early retirement package. Some wished to take a lump sum payout versus staying in the retirement program. This required additions monies to be paid up front. Our employee retirement program is fully funded. In addition, the lump sum payouts will decrease the future financial impact to the retirement fund. As it turned out a third of that draw down is not needed at this time.

The biggest news to me was the anticipated completion of the ERP program (our computerized database program). The new program was created to combine three different databases (contributions, AA store, and membership). The AA store and the contributions are up and running. I used the Contributions online and it went well. The membership section is scheduled to be up and running by the end of the year. The big difference is that our Area Registrar will have more control over the data. It is proposed that the Area will be making the changes directly. GSO has asked the Area to have an assistant Registrar to be fully trained. The greatest news is that the Delegate and the DCM's will have the ability to review what is in the "system" and process group change forms and send them to our Area Registrar and the corrections will be immediate. The ability to have this local control over the input and ability to correct information in the system is huge. In the past, the corrections were slow to be completed and many times just were not corrected. The Delegate and the DCM's will not be able to make changes, but our local Registrar will handle the changes. I know that our Area 54 Registrar has been keeping our Area database up to date. But, when the new system becomes operational, she will need some time to correct the main database.

As members, GSR's and DCM's, we now have a **HUGE** task to find out which groups are meeting in person or virtually or in a hybrid format. With the closure of so many groups, it is hard to find out which groups are open and which groups have closed permanently.

The GSR's/DCM's will need to fill out the group change forms and send them to our Registrar. The forms can be found on our website on the right hand side of the site. Look for the "Group Change Form." We all need to see that our group information is current. Please help your Group Service Representative (GSR).

## FROM THE EDITOR

### ROTATION

There was an article in the June 1996 issue of the *AA Grapevine* titled "The Spirit of Rotation." At the beginning of that article the author, Don P. of Aurora, Colorado, asks the following question: "How then can we continue to benefit from the experience of those who have rotated?" The article concludes with the answer to that question, "The best way I can think of to benefit from their experience is to be certain that they are a part of *mine*." (<https://www.aagrapevine.org/magazine/1996/jun/spirit-rotation>, accessed 11/17/2020). Don's point is simple. When I rotate *from* a position it is my responsibility to share the experience, strength and hope gained in that position with the AA rotating in. But it is a two-way street. It is also my responsibility as one rotating into a position to reach out to the AA rotating out. (The article is important to me for another reason. It was in June 1996 that I was first introduced to AA.)

This is the time of year in Area 54 when we experience the pains and gains from what we call rotation. It is not just an action, it also embodies the very spirit that is the foundation of AA.: One Alcoholic helping another. We need to remember that it is not just a game of "musical chairs." In that game someone gets left out every time, and there are rarely any "new players." In our "game" it should be just the opposite - always room for one more. Unfortunately, some have "politicized" the process, resulting in winners and losers. We see it in our jockeying for position, as well as in our lack of willingness to serve. We even see it in the language that we use. I have heard AAs say that they were "running for office." And I have also heard others say "I ain't volunteering for nothing." Perhaps it is time to pause and review where this whole idea of AA rotation came from in the first place.

It has been said that the idea of rotation actually came from right here in Area 54. In the early 1940s Cleveland experienced exponential growth in AA. To maintain some semblance of unity among those groups a Central Committee was formed by one of the early Cleveland AAs, Abby G., who set the committee up with time limits on leadership. I have heard that Bill W. credits Abby with inventing AA's traditional Spirit of Rotation. (<https://www.aacle.org/what-is-aa/history-of-a-a/>. Accessed 11/17/2020)

The Spirit of Rotation is at the foundation of our Second

Tradition, which provides, in short form, "For our group purpose there is but one ultimate authority - a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern."

Speaking of a "loving God," I know at least one AA who calls the "hat" "the God Box." When we cannot reach "substantial unanimity" in electing a servant to a position, we "go to the hat." I suppose it is similar to letting go, and letting God. But perhaps there is another consideration before a candidate forces a "hat." That consideration is ego.

I remember once standing for a position, with one other person also standing. By the third ballot it was clear that we had a divided house. The tally was very close, and with each ballot the tally remained about the same (pretty typical in a two-person election). Rather than putting the entire Assembly through the grueling process of voting again, and then deciding whether to vote one more time, before "going to the hat," it occurred to me, "Just sit down!" I did, thereby "conceding" the election. It opened so many more opportunities to serve that now I am sure the voice saying "Just sit down" must have been the voice of God.

The whole point of the Spirit of Rotation is to protect us from our own ego. Sometimes when we "Just sit down," we are doing the same thing Bill W. did when he called Charlie Towns back and said essentially, "Thanks, but no thanks." (See *Twelve Steps and Twelve Traditions*, pgs.136-138)

In 1955 AA "Came of Age," and Bill W. became an "elder statesman." Basically, he "just sat down." Perhaps we too might come of age. Certainly, for those who stood but were not elected there will be many, many opportunities to continue to serve. Remember, "The harvest is plentiful but the workers are few."

Manager of the General Service Office. Our current General Manager, Greg T., will be leaving his office February 1, 2021. He served as a trustee and other volunteer positions before working at GSO for the past 8 years – the last 6 years as our General Manager. He has led us through some vital changes and updates. He has helped streamline many of our operations. I am grateful for his service.

In Spring, 2021, *La Viña* (our Spanish Language version of the Grapevine) is expected to release the publication "Voices of Women" in Spanish. *La Viña* continues to struggle financially. Grapevine will publish a book for prisons, "Free on the Inside."

Another update: the AA warehouse has received 2,000 Big Books and the back orders are now being filled. The Summer Sale of 10% off a case of Big Books cleared out the warehouse.

There are some nice articles about the staff members that are retiring. These stories can be found in the Box 459 Online Supplement October 2020 edition which I found at the [www.aa.org](http://www.aa.org) website.

We also have a new Chief Financial Officer (CFO), Paul Konigstein (nonalcoholic). He comes to AA with 30 years of experience working for nonprofit organizations. This is good news as we are going through a difficult financial experience.

### **"All About the Money"**

As of 9/30/2020, thanks to all the members and groups of AA, the contributions are 62% of our income and literature is 38%. In 2018, the literature was 58% and contributions were 42%.

With print publications decreasing because of e-books and the ability to download one copy of each pamphlet from the AA website, our projected literature sales will continue to decrease.

To look at the 2020 monthly numbers, Literature Sales fell from \$1.3 million in January to \$272,401 in April. They rebounded slowly to \$940,959 in September. The Contributions monthly were \$1.8 million in January and after falling to \$0 in April rebounded to \$1.1 million in July. Thank you to all members of AA. For the future, if all the members of AA sent \$10 every year, AA would be fully self-supported. I speculate that the Big Book would cost less.

Grapevine is facing some challenges in this COVID-19 pandemic. There were several cancellations of events to sell book and subscriptions including the International Convention. In addition, the number of subscriptions fell off. So financially they are taking a loss this year.

Grapevine offers a great opportunity for 12-Step work. With folks not able to get out to meetings and some having difficulty getting online for meetings, a Grapevine subscription would be a great gift. This is a great way to 'Carry the Message'. Grapevine is our meeting in print (or online).

Thank you for helping me serve as your Alternate Delegate. Our outgoing Delegate, Shyrl B., made my job much easier in many ways. She guided me and helped me. As with all rotation, I just now have begun to figure out what the Alternate Delegate does. Now, it is a new chapter and Past Delegates, I will need your guidance. Thanks for your faith in me.
