### *Mixing It Up*

*We are average Americans. All sections of this country and many of its occupations are represented, as well as many political, economic, social, and religious backgrounds. We are people who normally would not mix. But there exists among us a fellowship, a friendliness, and an understanding which is indescribably wonderful.*

*(Big Book, p. 17) \**

This statement sounds real nice. It comes from the beginning of Chapter 2 (There is a Solution) of our "Big Book." However, I wonder, "Is it fact, or is it aspirational?" There is another similar statement that a dear friend of mine used to say "We may have come on different ships, but we're in the same boat now." That statement has been attributed to Rev. Dr. Martin Luther King, Jr. Dr. King was directing our attention to a problem. The Big Book writers were suggesting a solution.

These statements are recognitions that fall under the broad term "Diversity." What is "diversity"? What are we really saying when we use that expression? If the Big Book statement is true, why does AA need separate pamphlets for so many different segments of our membership? What is the point of having "specialty groups"? Doesn't all that fly in the face of our Traditions?

Tradition One reminds us that our common welfare comes first and that personal recovery depends upon AA Unity. Although anonymity may be the "spiritual foundation of all our traditions," Unity is the overarching foundational necessity that keeps AA from falling by the wayside. It is the basis of, and the first of "Twelve Points to Assure Our Future." Yet, in practice, we continue to divide our fellowship on the basis of some of the very things that we recognized early on as making us "people who normally would not mix." Oh, I left out a very important word from that first tradition: "Our common welfare **SHOULD** come first..." That one word tells the whole story. The idea of unity - even in diversity - **IS** aspirational, not factual. That unity is what we aspire to have. It is not necessarily what we actually have.

The concept of unity in diversity might be contrary to the principle of "substantial unanimity" that we cherish so much in General Service. The idea of "substantial unanimity" (in practice, "super majority") is imbedded in the 12 Concepts for World Service. It is one of the General Warranties contained in the Twelfth Concept. Again, words are important. Warranty Four actually states "that all important decisions be reached by discussion, vote, and, **whenever possible**, by substantial unanimity." The "whenever possible" part is a two edge sword. On one hand it recognizes that we are diverse; on the other hand, it recognizes that we are diverse! Because of our diversity the considerations of all must be included in order to make "important decisions." Yet, our diversity may keep us from reaching substantial unanimity and could leave us unable to make an important decision.

These are just a few thoughts that come to mind when I think of the idea of Diversity. As you can see, my thoughts raise many unanswered questions. But on May 21, 2022 perhaps we can have a discussion to begin answering these questions. On that day, the Cleveland North Coast Multi-District will hold a workshop on the topic of Diversity. You, too, may have questions about the so-called commitment to diversity that AA claims to have. Come to the workshop. We might just learn something from you.

### **Declaration of Unity**

This we owe to A.A.'s future; to place our common welfare first; to keep our Fellowship united. For on A.A. unity depend our lives, and the lives of those to come.

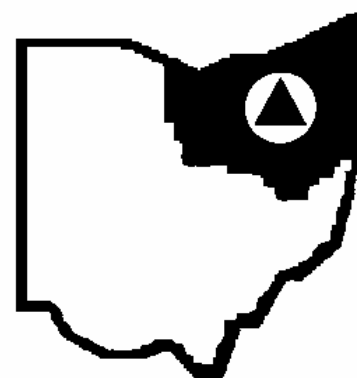
