## F. Review progress report regarding update of the pamphlet "A.A. for the Native North American."

Consensus after review: Are they going to have literature for two Spirit Indigenous people, e.g. Gay, LGBTQ? No vote required.

G. Review progress report regarding development of a fourth edition of the book Alcoholicos Anomnimos-Spanish

Committee reviewed and supported the development of the 4<sup>th</sup> edition of the book Alcoholicos Anomnimos-Spanish No vote required.

H. Review progress report regarding the translation of the book Alcoholic Anonymous (4<sup>th</sup> edition) in plain and simple language.

Consensus upon review: Changing and translating into plain and simple language will lose important language with our history. We should not deny anyone the opportunity to receive our message. e.g., Lower than 5<sup>th</sup> grade reading level. Suggestion: Change from a translation to a study guide of our current edition. Vote: 10 voting members, 3 For 7 Against. Committee Took No Action.

I. Review progress report regarding development of a Fifth Edition of the book Alcoholics Anonymous.

Consensus after review: Reviewed and no comments. No vote required.

#### J. Review revised draft of the existing version of the pamphlet "Twelve Traditions Illustrated."

Item J was omitted and F was added No Vote II - Committee

C. Consider the list of suggested Grapevine book topics for 2024 or after. The committee selected all six topics presented.

Consensus after consideration: 1. Take into consideration performance of similar title. e.g., For profitability. 2. We agreed the 6 proposed Book/Topics should be produced. No vote taken.

D. Consider a request to provide all area alternate delegates the same Conference materials as sitting delegates.

Consensus after consideration: Agreed that alternate delegates should receive the same conference materials. Item not forwarded. Policy and Admissions

#### A. **Review GSO general manager's report regarding General Service** Conference site selection.

Consensus after consideration: Review GSO general managers report regarding General Services Conference Site selection. Motion made and seconded to recommend further research on site selection. Vote: 9 For, 4 Against. Motion carried. Not forwarded to Mini Conference. D. Discuss report on the Equitable Distribution of Workload process. The committee discussed Equitable Distribution and workload process. No vote required.

Group III

Chair: Calvin L., Moderator: Sam P., 11 members attending, Decided

the vote would be by substantial unanimity. Corrections

D. Consider a request to include content in existing A.A. literature on sponsorship on persons in custody by outside members of the Fellowship.

Consensus Additional Considerations: This will involve corrections working with Literature and CPC. Request for a cost analysis of what it will take to update 17 items of literature. The committee vote was 11 For and 4 Against.

The Committee presented the motion to the Conference. After discussion, the vote was 68 For, 0 Against

Agenda

A Review suggestions for the theme of the 2024 General Service Conference.

The committee review and selected: #11 – Carry the Message, Our Vision for the Future , #18 – Unity Together in our Diversity. #26 – AA Comes of Age, Again. Mini Conference voted to accept these recommend themes Vote: -60 For, 1 Against.

C. Discuss workshop topic ideas for the 2024 General Service Conference. Committee selected: #9 – Trusted Servants, not Governors; #24 – What is the Newcomer Hearing. #35 – How service is so important to keeping your sobriety. Consensus upon discussion: Not enough sponsors have their sponsees do any service work at all. Mini conference voted to accept these topics. For 67, Against -0.

E. Discuss progress report on Conference improvement. Consensus upon discussion: Glad to be able to review a progress report. Glad to see there is a contingency plan for world events. Approved the ask for Delegates to provide AV for their area. No Vote Required.

IV - Committee

Chair: Kimberli A., Moderator Christine F., 14 members, 12 voting members attending, Decided the vote would be by Simple Majority Treatment and Accessibilities

E. Consider request to do an Accessibilities Inventory of Alcoholics Anonymous throughout its services and structure.

Consensus upon considerations: This is asking GSO to do an accessibility inventory of literature and services provided. What are we already doing? What is working and what is not working? Reminder our primary purpose is to help the sick and suffering alcoholic, whomever they are and wherever they are. The intent of this inventory is to identify areas for improvement in carrying the message to those with accessibility challenges. Background information shared on various disabilities: Physical, Hard of Hearing, Sight, Mental/Cognitive, Language Barriers, Remote Communities and Elderly Persons acquiring disabilities as they age. Consider the scope of this inventory. Disabilities are so widespread. Will it focus on the disabilities mentioned in the background information or try to identify other disabilities? How will it consider materials already available to AA? Reminder that all groups are autonomous and can do group inventories if there are accessibility concerns. Questions on what will be selected to be inventoried, physical accessibility, cognitive impairments, etc.? Is this something that should be a home group or community wide issue and not necessarily an AA issue outside of the resources already provided? Much discussion on the first plain language Big Book which is in development with a variety of opinions (which we realize was not the scope of our ask) .Voted: 7 For, 4 Against, 1 Abstained.

Item move forward to Mini-Conference -1 For , 64 Against.

I wish to talk about money which is our finances in A.A, To begin, I want to say there are no dues or fees for membership in AA. We are self-supporting, which means we take care of our own selves. That means we pay our own rent, utility bills, buy our own coffee, snacks and literature at our Home Group.

Self-supporting also means each one of us is privileged to give to GSO (General Service Office) which is our office in New York. GSO take care of Group Services, Box 459, General Service Conference, Loners Internationalist, Regional Forums, Archives, Corrections, Treatment and Accessibilities, Publishing of Literature and Big Books (all our books) and all Administrative needs of the Corporation. [The 12 Concepts as explained in the Service Manual explains our corporation.] We do not get any money from government, city, churches or any other organization. We are self supporting. So individuals can be self-supporting by giving in the Birthday/Anniversary Envelopes. One dollar (\$1.00) for each year of sobriety is suggested. When someone announces they have a AA birthday or anniversary, we give them an envelope.

We all cannot be Delegates, General Service Representatives (GSR), or District Committee Members (DCM), but we ca all show gratitude by giving. We can do this online, at AA.org and use our bank card or credit card..

It cost GSO at least \$7.00 to \$8.00 per member of

AA to keep the doors open and to service the membership. With that being said, let us pass out the envelopes to our home group members and each one of should be giving at least \$3.00 in the basket and \$5.00 in the home group basket.

Remember: Putting that \$1.00 in the basket is not enough anymore. \$3.00 at outside meting and \$5.00 at our home group. \$3.00 equals \$1.00 for Unity, \$1.00 for Service and \$1.00 for Recovery. **GIVE UNTIL IT FEELS GOOD!!**

F. Discuss carrying the message to alcoholics with intellectual or information processing challenges, communication challenges and diverse neurological abilities. Consensus upon considerations: What does the Delegate need to know? How does your group or how has your group carried the message to alcoholics with intellectual or information processing challenges, communication challenges, and diverse neurological abilities? As a group and within our home groups, we are not qualified to help with specific disabilities, but we are able to carry the message the best we can in each situation Stick to our primary purpose of helping another alcoholic, whom ever they are. Utilizing existing pamphlets such as the AA Literature for Alcoholics with Diverse Accessibility Needs Examples - easy to read, illustrated pamphlets. What does your group think are the best methods to reach alcoholics with these challenges and/or diverse abilities? Why is this an Agenda Item for Treatment and Accessibilities? Is this a better fit for CPC? We recognize that there are other organizations and resources available for this specific group, and we want to be able to bridge the gap while still staying in our alcoholic lane. Serve as a resource to our county Mental Health and Developmental Disabilities Boards. Collaborate with CPC Committee to create workshops for corrections, hospitals and treatment facilitates staff. How do we energize our districts to do this type of work? Believe new pamphlets are not necessarily the answer for this specific population . No vote required. International Conventions/Regional Forums

Committee Motion: The committee recommends that throughout our literature, service pieces, guidelines, reports and on the AA org website; any place where it is found to be unclear that our voluntary AA contributions are made payable to the General Service Board although they are sent to the General Service Office for processing. Vote 8 For 0 Against. Committee agreed. Forwarded to the Mini Conference. Discussion included 1) GSB receives money; checks should be made out to General Service Board. 2) GSO performs the processing. 3) Any place where address is unclear needs to be changed.
