# **Area 54 Assembly Minutes**

## Opening:

**DeVona S.** opened the Assembly at 2:03 p.m. with the Serenity Prayer. Carolyn G. read the 12 Traditions. Leslie N. read the 12 Concepts. Bob M. gave a summary of Tradition 5. Bob D. gave his interpretation of Concept 5.

## **Recording Secretary:**

**Joan S.** presented the minutes. No corrections or additions. Motion by Charles M. and seconded by Val D.to approve minutes. Motion approved.

# **Mailing Secretary:**

### **Registrar:**

### **Treasurer's Report:**

Candy presented the third-quarter treasurer report. Total contributions for April through September are \$11,310. Total expenses that same period are \$19,048.61. By the end of December, she will give us a report that shows how that compares to what we have budgeted.

Candy stressed we are not in the negative because we already have a balance and money is continuing to come in. James T. said the starting balance and current balance should be included. Candy said that will be included on the report at the end of the year. Bob M. said he would also like to see a balance sheet.

## **Committee Reports:**

**Karen S.,** chair, Cooperation with the Professional Community: The Public Sector HR Association has invited us to have a table at their event Sept. 29-Oct. 1 at the Hilton Cleveland Downtown. She has a sign-up sheet if you'd like to volunteer.

**Mindy M.,** chair, Public Information: The last of the literature packets are going out tomorrow, thanks to donations from the Cleveland Intergroup Office. The committee is following up with nursing homes and other places that have asked for information.

**Mae R.,** chair, Finance Committee: With inflation, the \$1 bill we put in the basket doesn't nearly cover what it costs the General Service Office for each AA member. To cover our costs, we would each have to contribute \$11 because of inflation. When the basket is passed, give what you can afford, or dig a little deeper and give until it feels good.

**Val D.,** chair, Accessibilities: She did not come to the mic. But her written report states that Nikki M. is stepping down as secretary and will be replaced by Rachel Q.

# **DCM Reports:**

**Jessie H.,** DCM, District 33: They are working on a district meeting for all their GSRs.

**Jeff C.,** DCM, District 60, and chair of the Akron Multi-District, said the fall seminar will be from 1-4 p.m. on Saturday, Oct. 18, and will feature several people speaking on general service, with a Q&A for new GSRs. As a DCM, he has been visiting meetings almost every day since July 3, in Districts 3 and 60, to explain the importance of having a GSR.

**Arnetta P.,** DCM, District 35: There are two new meetings at the Hitchcock Center for Women, three groups moving from District 35 to 33, and two groups that are closed. She's visiting groups that are still active.

### **Intergroup Liaison Reports:**
